CAUTION

On October 6, 2012, at approximately 11:31 a.m., the suspect entered the U.S. Bank located at 630 East Bell Road in Phoenix, Arizona, and ran to the teller counter. The suspect pushed a customer who was standing at the counter aside, then pointed at the victim teller's open drawer. The victim teller gave the suspect a known quantity of U.S. currency. The suspect fled the bank and ran westbound behind the business.

The suspect was described as a White male, approximately 25 years old, 5'7" to 5'10", with a skinny build and blue or green eyes. He wore a black ski mask with a striped pattern, a black, long-sleeved jacket or pullover, black gloves, blue jeans, and black shoes.

On December 6, 2012, at approximately 10:49 a.m., the suspect entered the BMO Harris Bank located at 34525 North Scottsdale Road in Scottsdale, Arizona, approached the victim teller, and made a verbal demand for money. The suspect was given a known quantity of U.S. currency then fled the bank.

The suspect was described as a White or Hispanic male, approximately 25 years old, 5'10" to 6'0", weighing 150 pounds. He wore a black ski mask, a white, long-sleeved, button-down shirt, dark pants, dark gloves, and dark wrap-around sunglasses.

On December 21, 2012, at approximately 3:06 p.m., the suspect entered the BMO Harris Bank located at 21911 North Scottsdale Road in Scottsdale, Arizona, approached an employee in the lobby, and pushed her as he walked past. The suspect approached another teller and verbally demanded large bills, then approached a second teller and did the same. While the suspect was making his demands he kept his left arm behind his body, suggesting that he was armed with a weapon even though none was shown. The suspect was given a known quantity of U.S. currency.

The suspect was described as a White male, 25 to 35 years old, 5'8" to 6'0", weighing 180 to 190 pounds with thick brown eyebrows. He wore a black ski mask, black "aviator"-style sunglasses, black gloves, a white pullover with a ¼ zip front, blue jeans, and tan or brown hiking shoes.

On February 1, 2013, approximately 11:46 a.m., the suspect entered the US Bank located at 630 East Bell Road in Phoenix, Arizona, and approached the teller. The suspect verbally demanded money from the teller, who complied and gave the suspect a known quantity of U.S. currency. He then fled the bank heading northbound into a neighborhood.

The suspect was described as a White male, approximately 40 years old, 5'8" to 5'10", weighing 140 to 170 pounds. He wore a black cloth ski mask, a white pullover sweatshirt, black gloves, and jeans.

On March 12, 2013, at approximately 10:59 a.m., the suspect entered the US Bank located at 630 East Bell Road in Phoenix, Arizona, and preceded directly to the teller counter where he pushed an elderly woman out of the way. He demanded money from the teller, who complied. The suspect then fled the bank and ran north into a neighborhood.

The suspect was described as a White male, approximately 25 years old, 5'11" with a slender build. He wore a black ski mask, black plastic sunglasses, a white long-sleeved shirt, black gloves, grey sweatpants, and tennis shoes.

On March 25, 2013, at approximately 3:15 p.m., the suspect entered the BMO Harris Bank located at 33703 North Scottsdale Road in Scottsdale, Arizona, and approached the victim teller. He verbally demanded money from the teller, who gave him a known quantity of U.S. currency before the suspect fled the bank.

The suspect was described as a White male, approximately 25 years old and 5'10". He wore a black ski mask, black sunglasses, black gloves, and a white long-sleeved shirt.
